This fund invests in high-torque, early-stage companies that have the potential to generate superior returns.

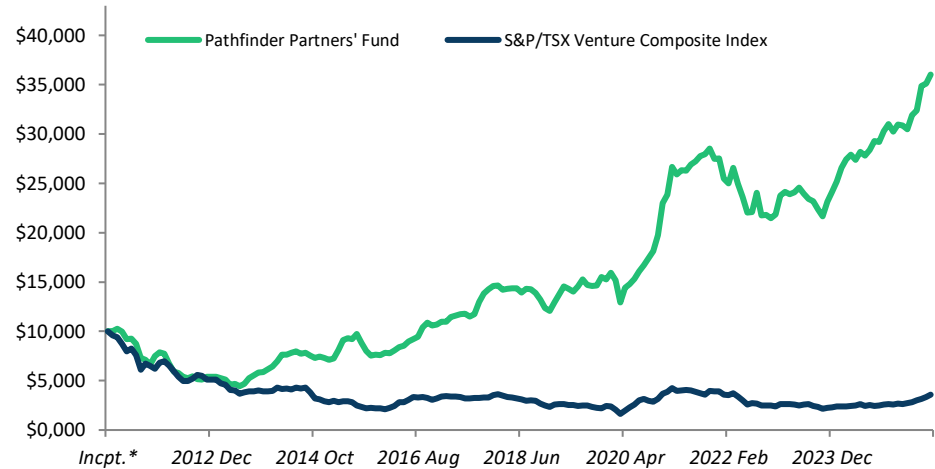

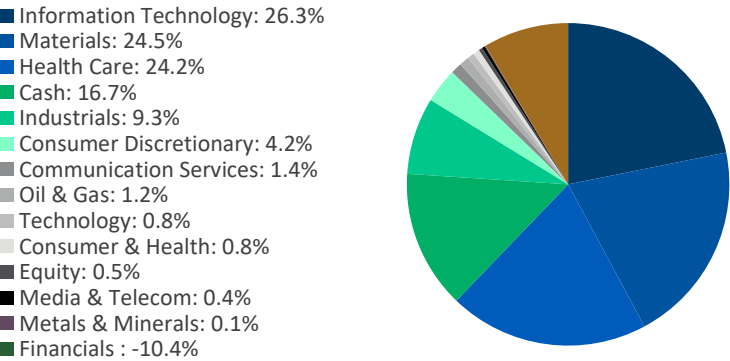
